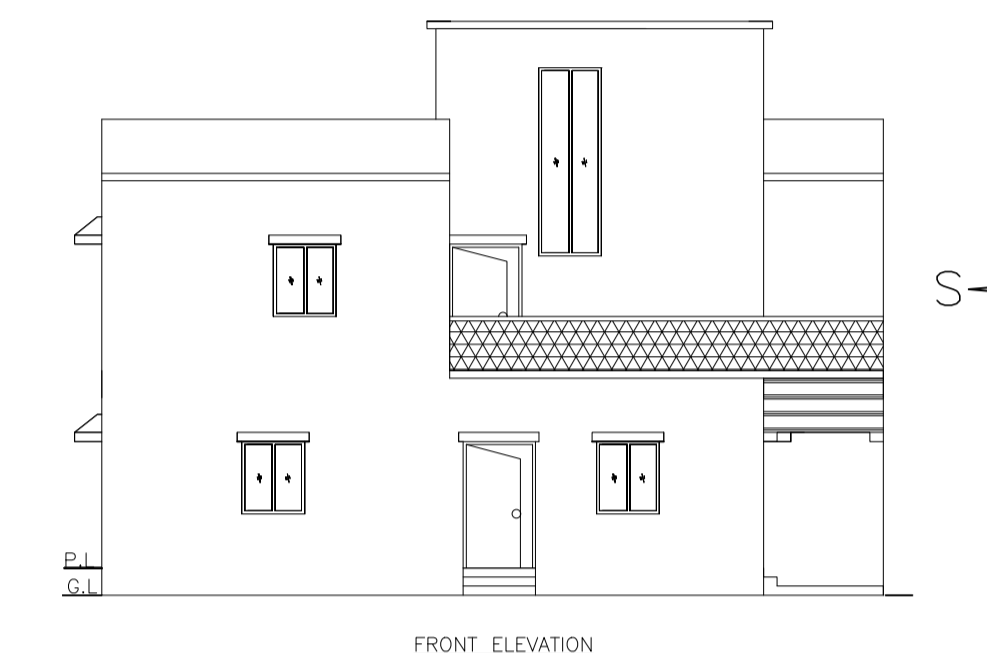
SECTION AT X-X



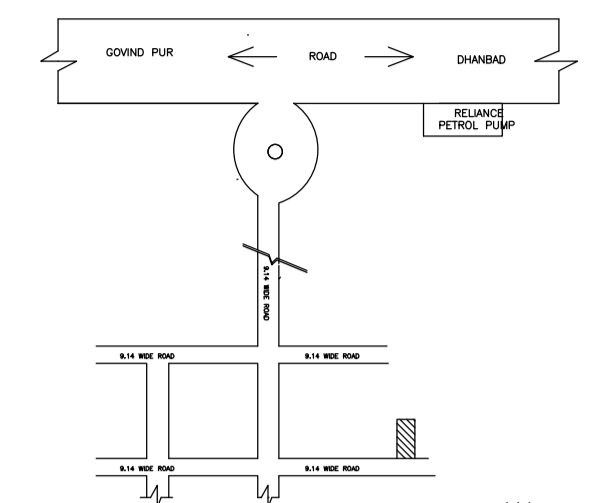

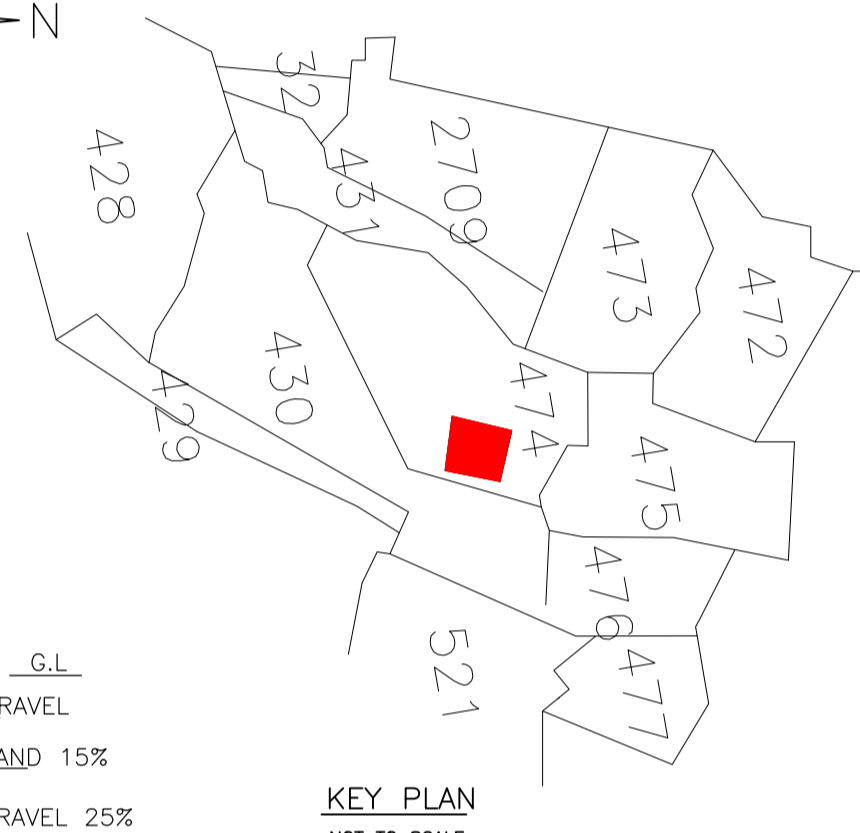
LEFT SIDE ELEVATION



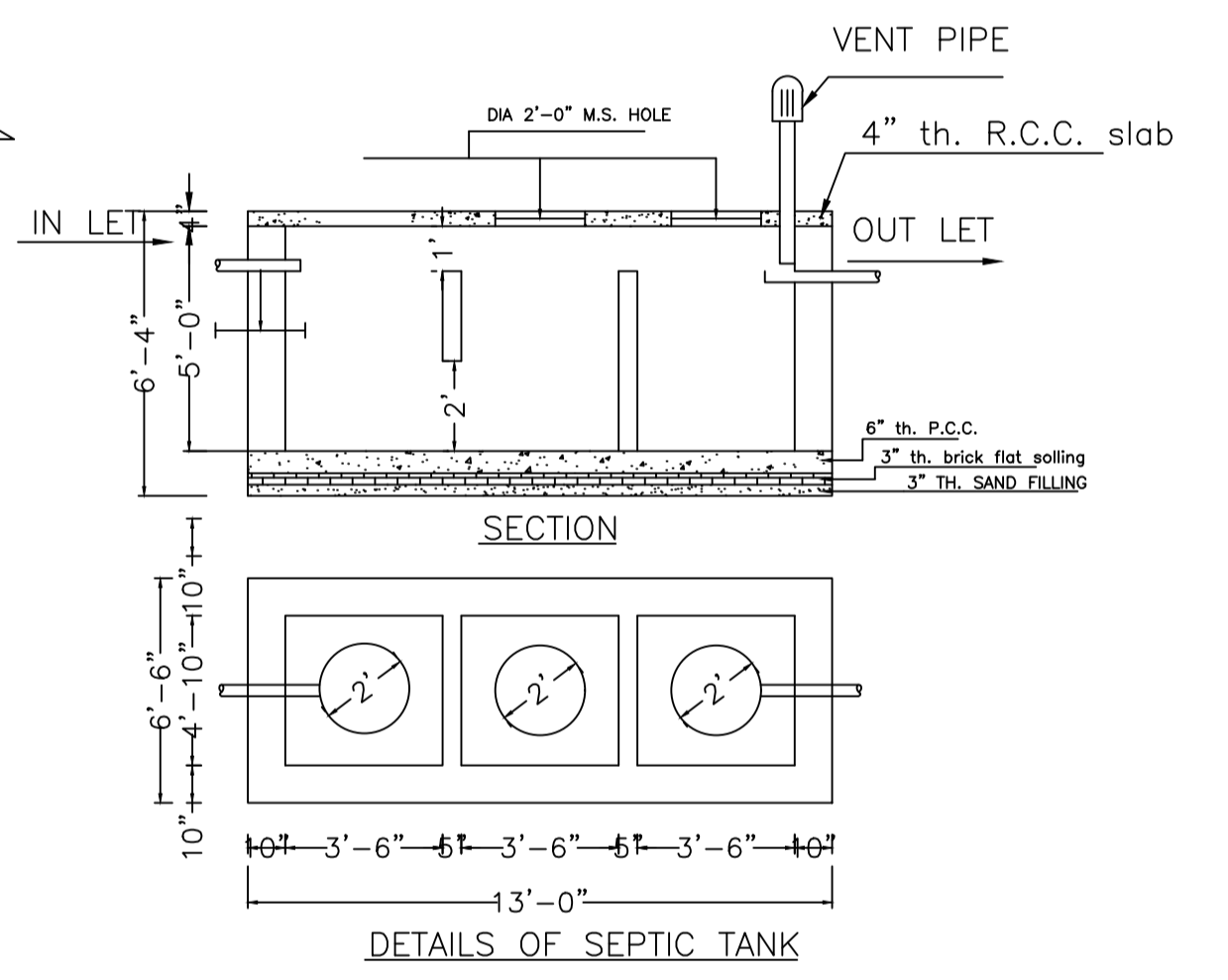
FRONT ELEVATION



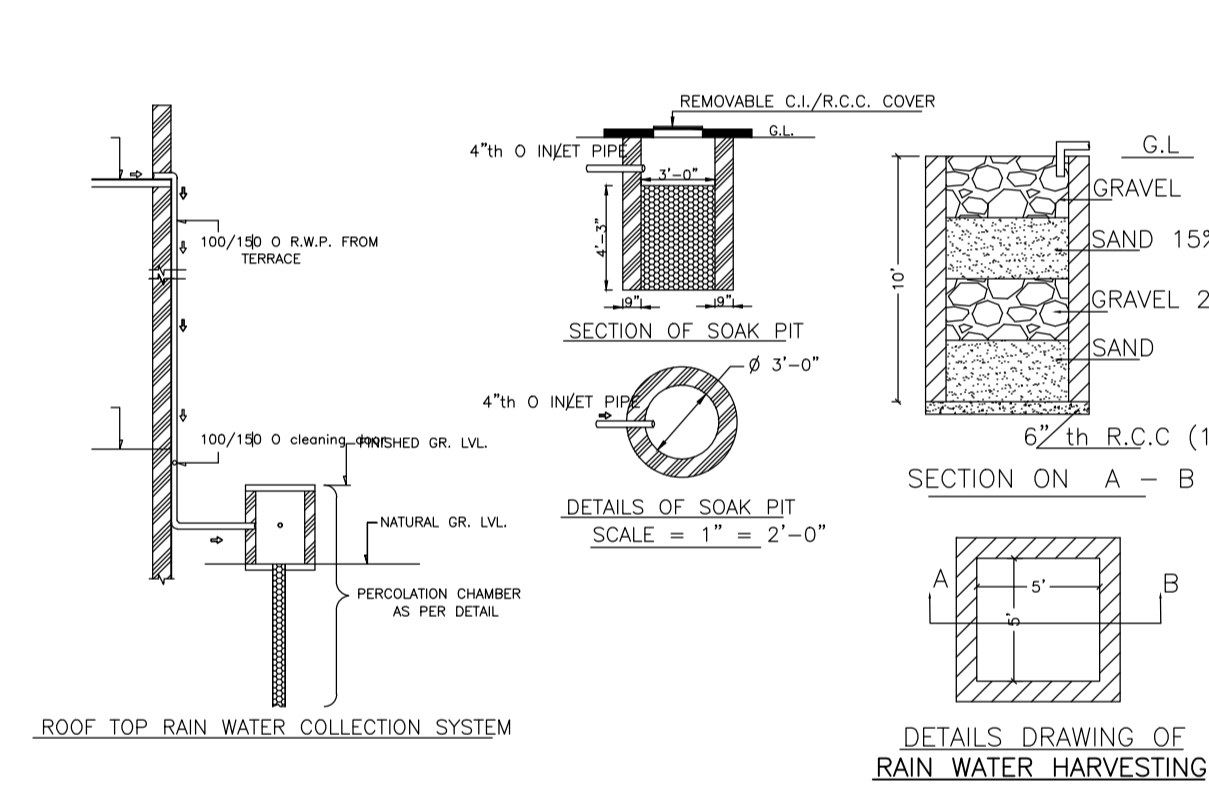
LOCATION PLAN

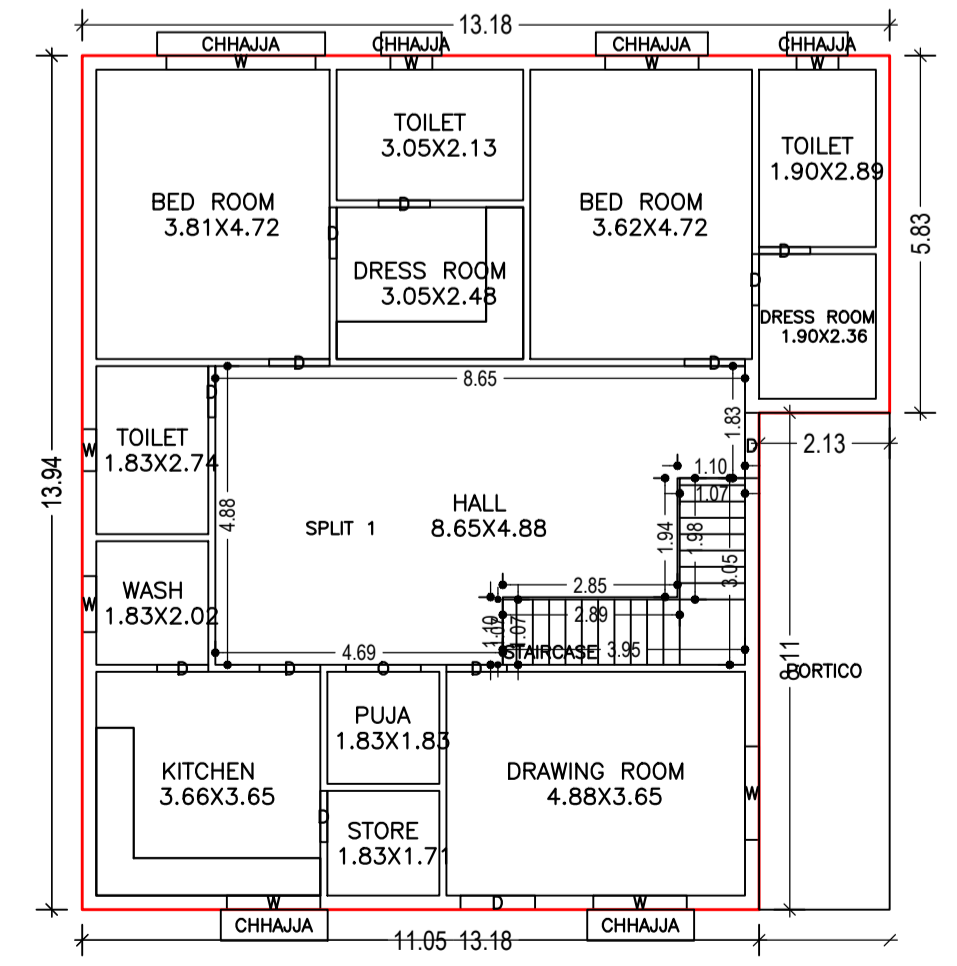
KEY PLAN

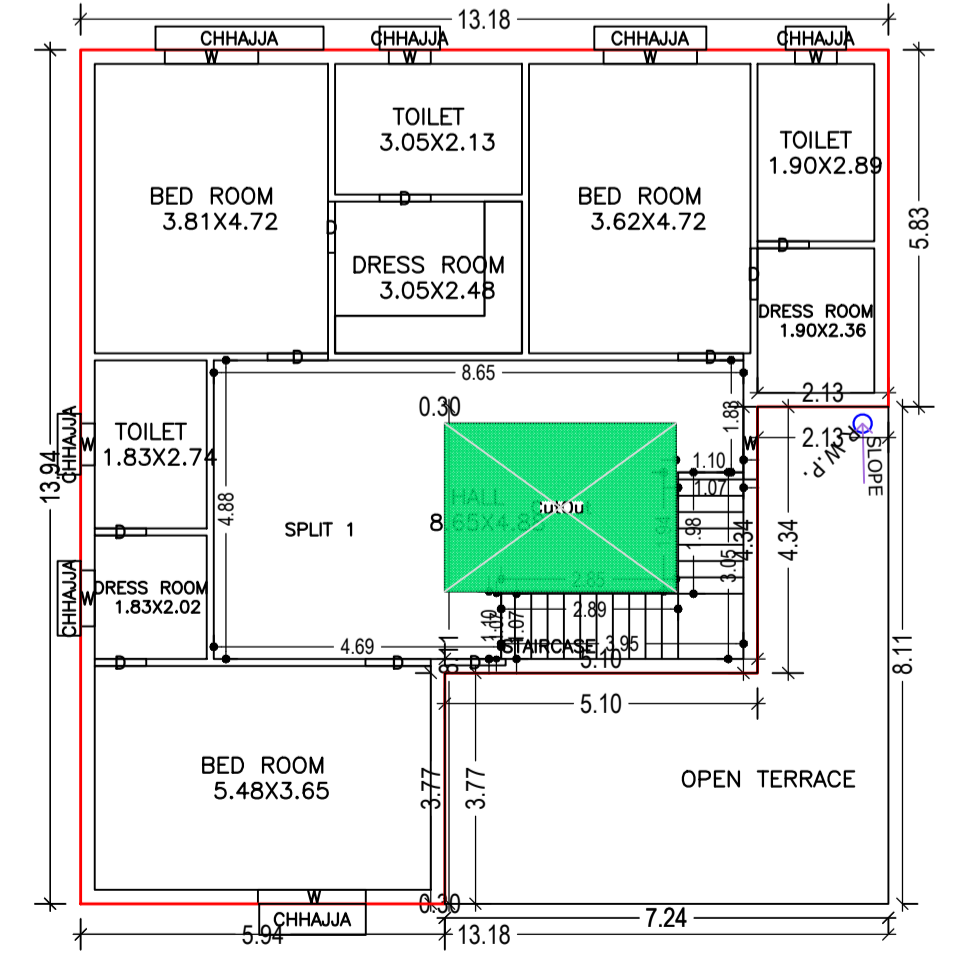
DETAILS OF SEPTIC TANK



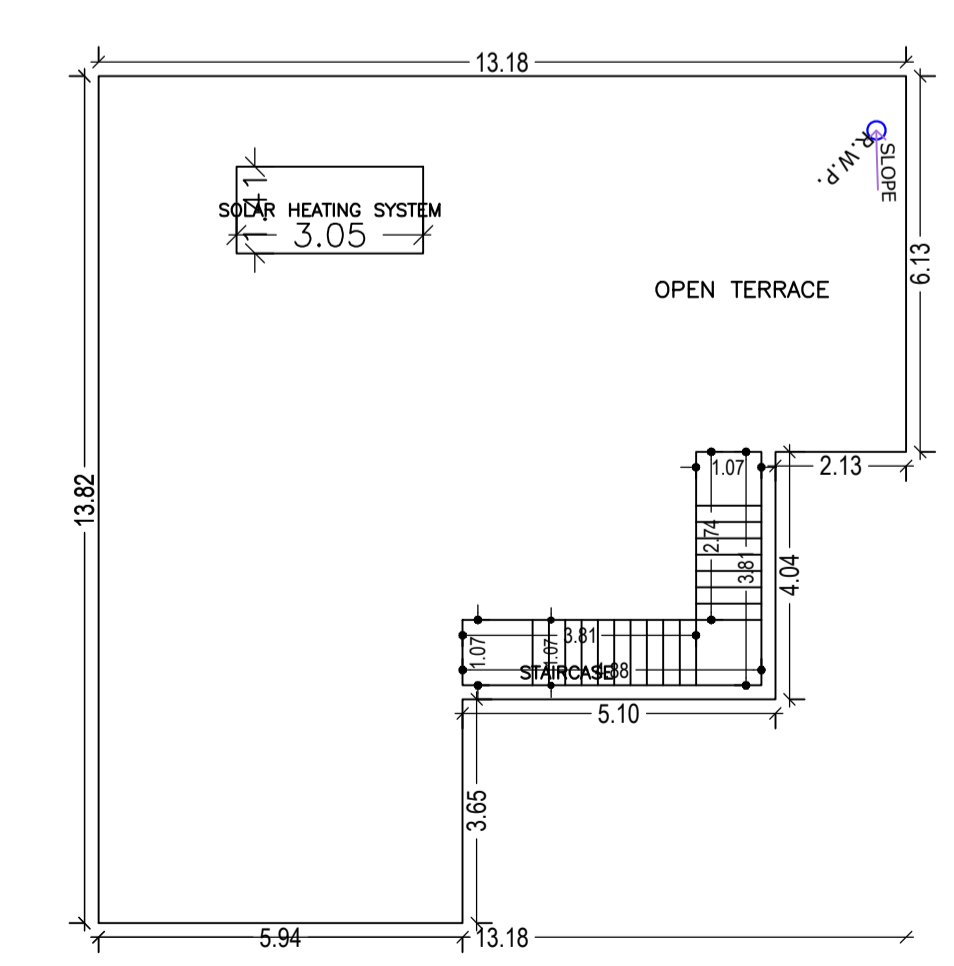
DETAILS DRAWING OF RAIN WATER HARVESTING



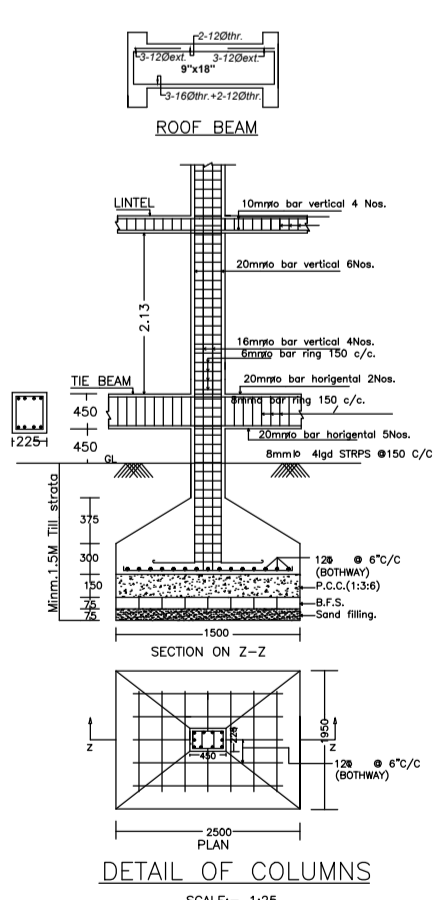
