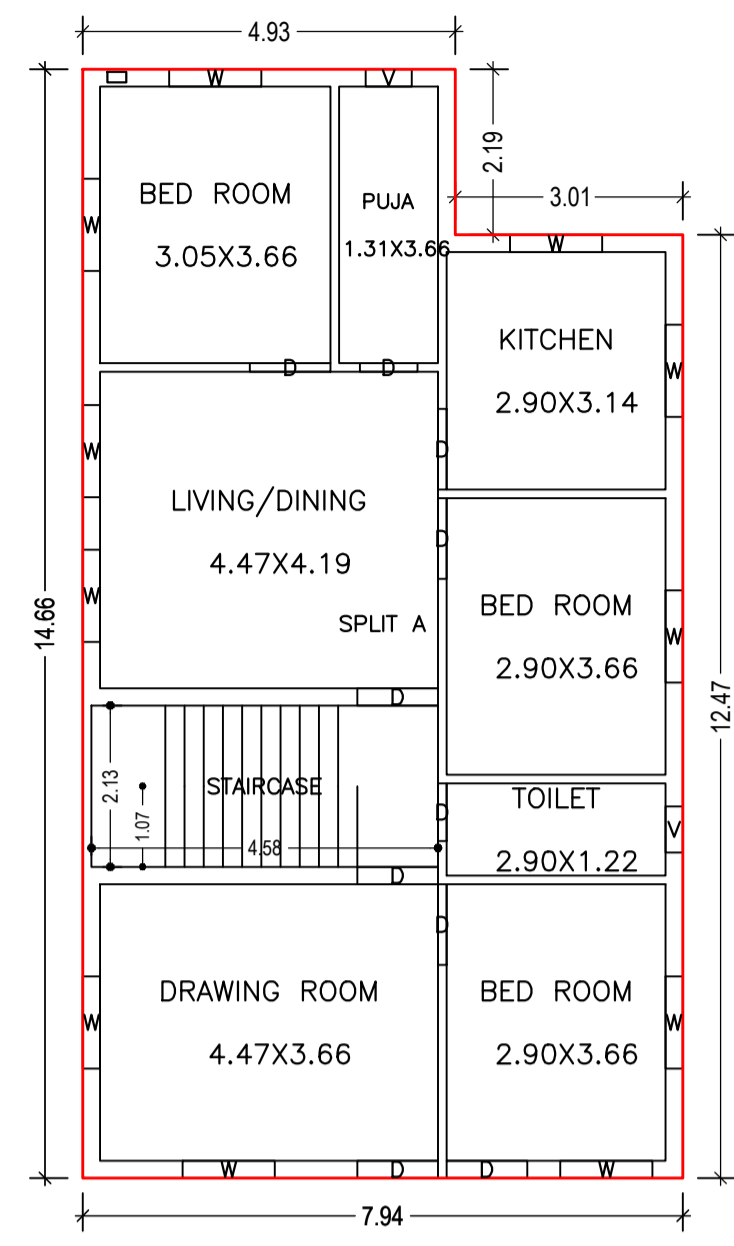

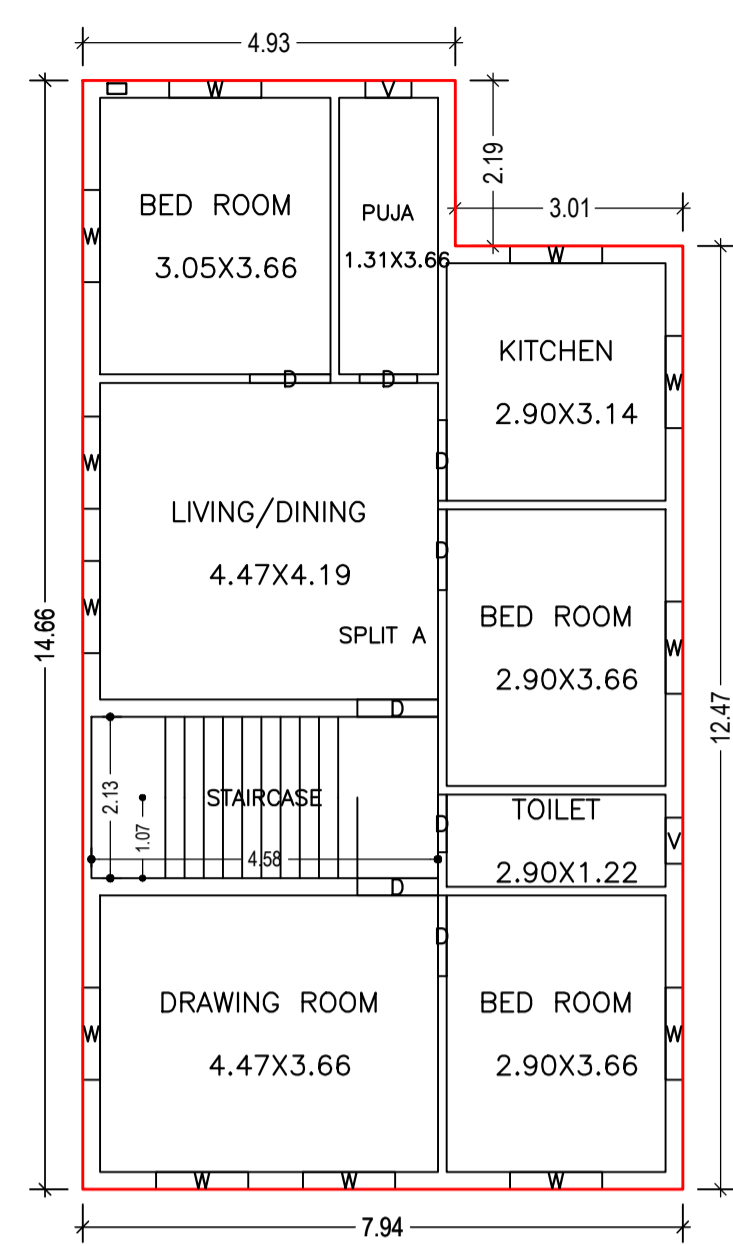

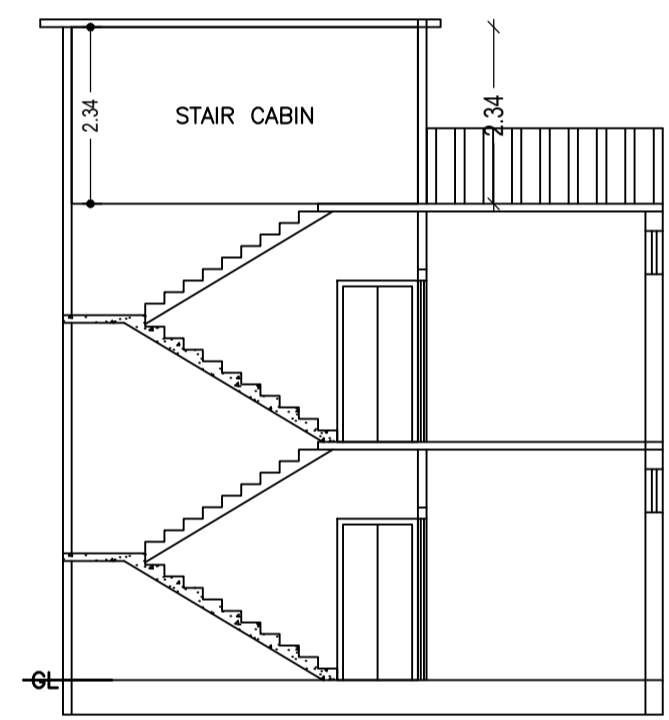
GROUND FLOOR PLAN (Proposed) (SCALE 1:100)



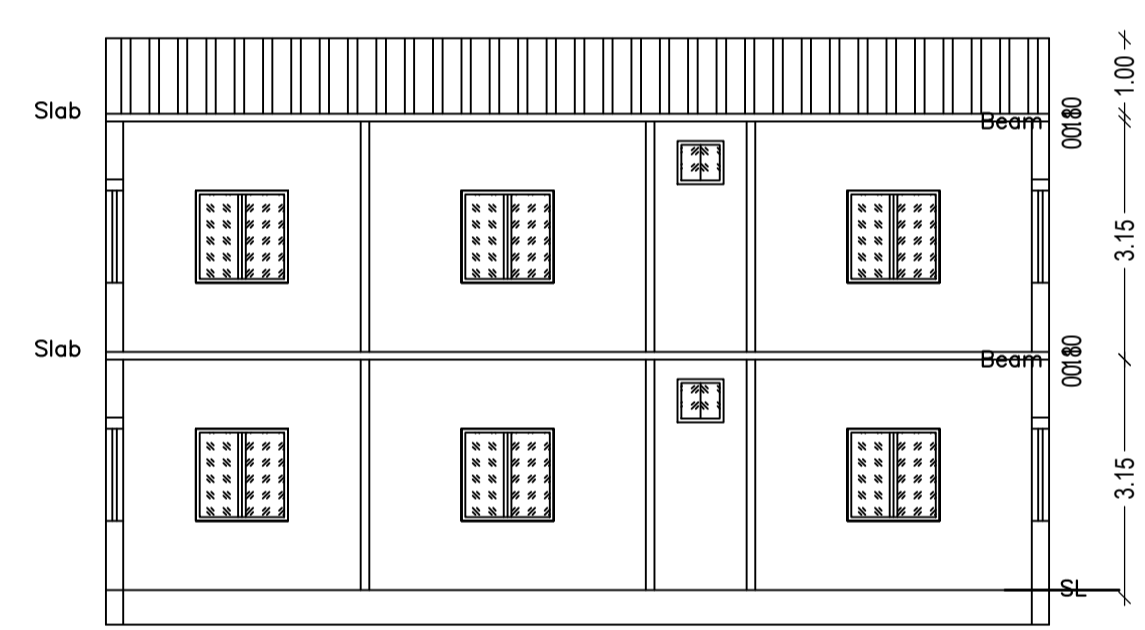
FIRST FLOOR PLAN (Proposed) (SCALE 1:100)



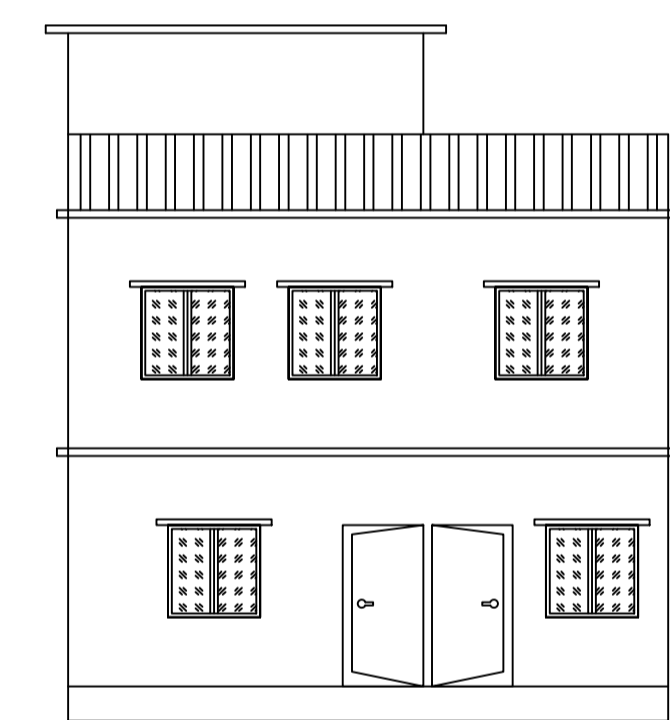
TERRACE FLOOR PLAN (SCALE 1:100)



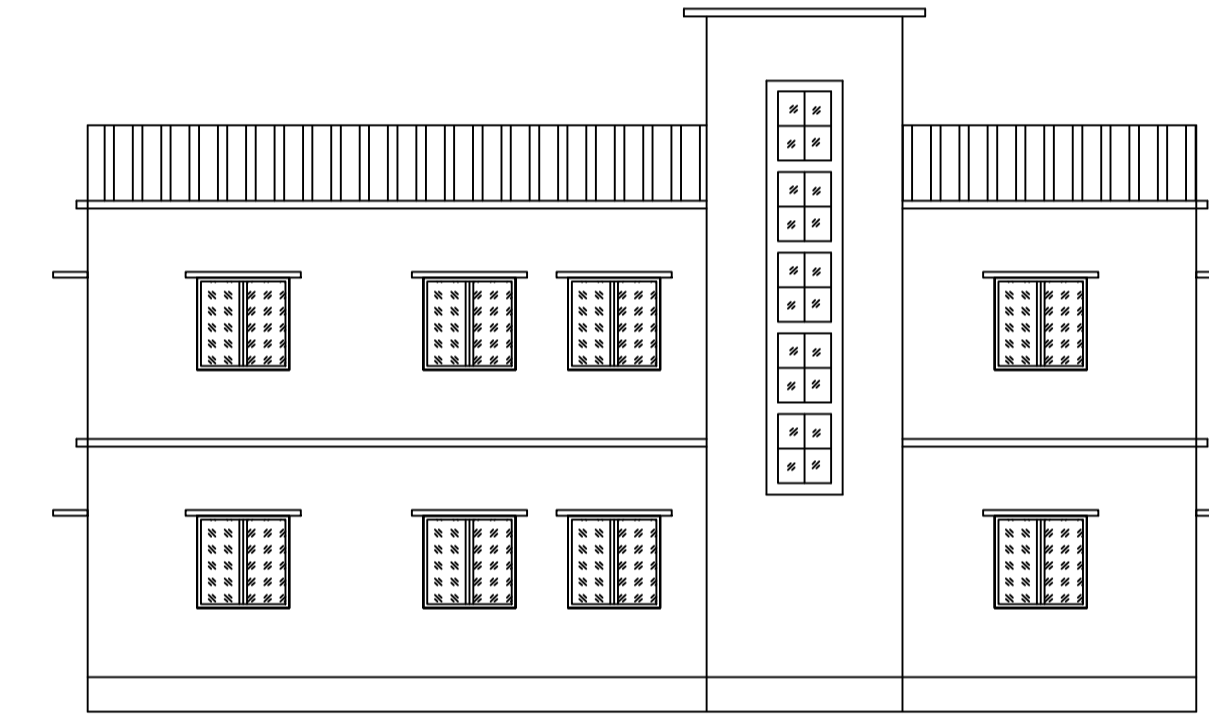

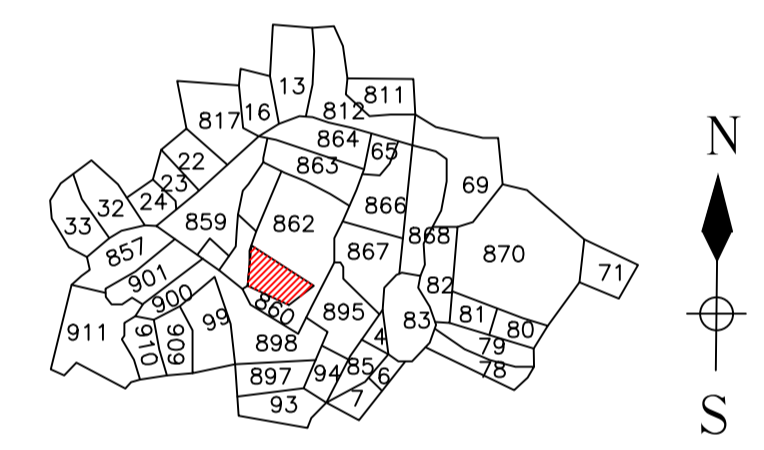

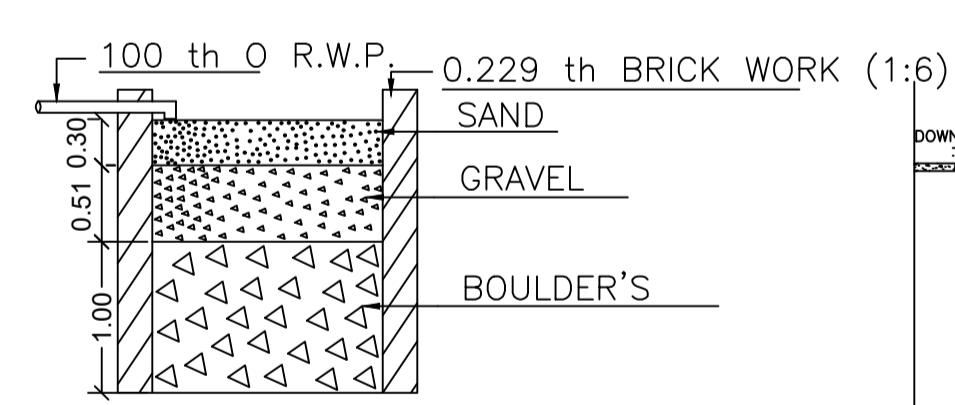
FRONT ELEVATION (SCALE - 1:100)



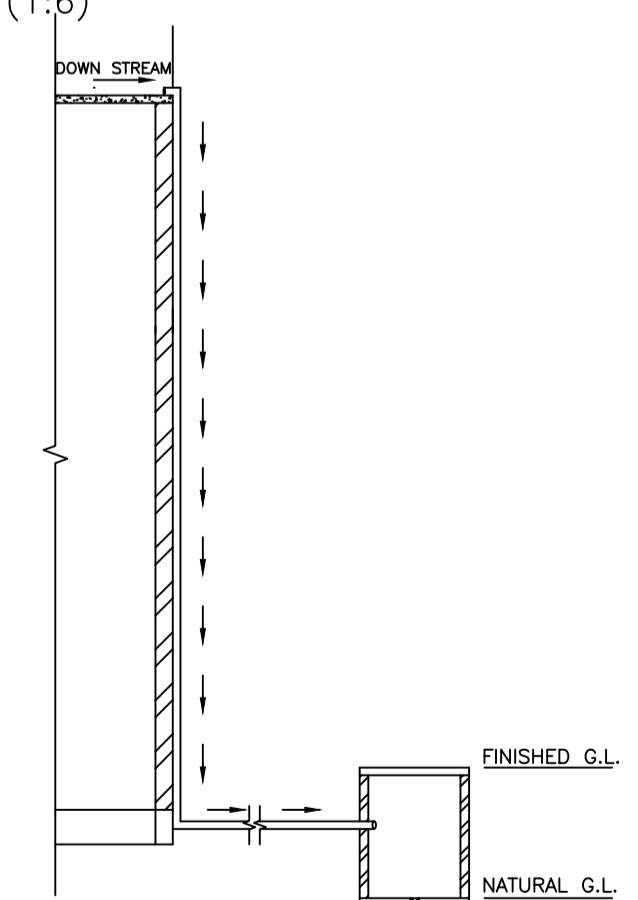
LEFT SIDE ELEVATION (SCALE - 1:100)



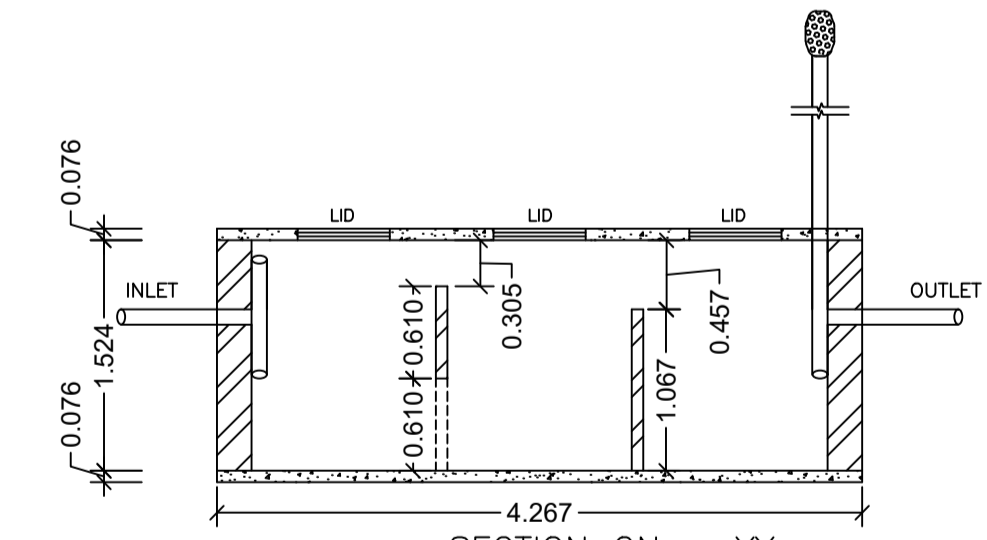

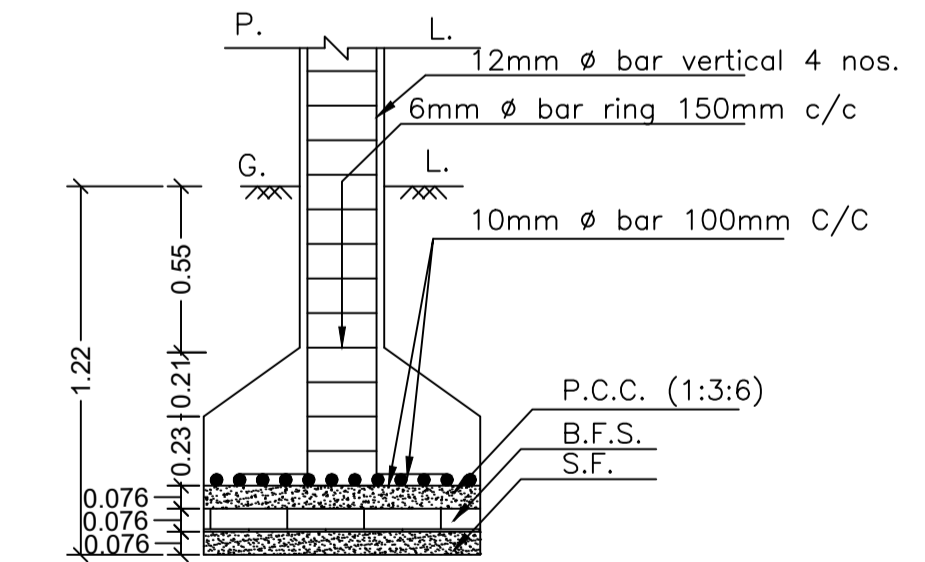

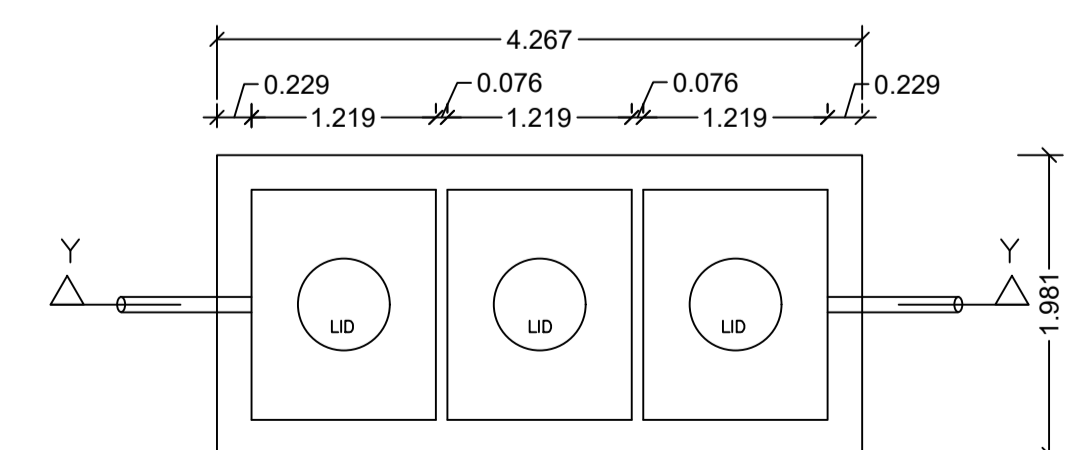
ROOF TOP RAIN WATER COLLECTION SYSTEM (SCALE: 1:96 (1\"/>



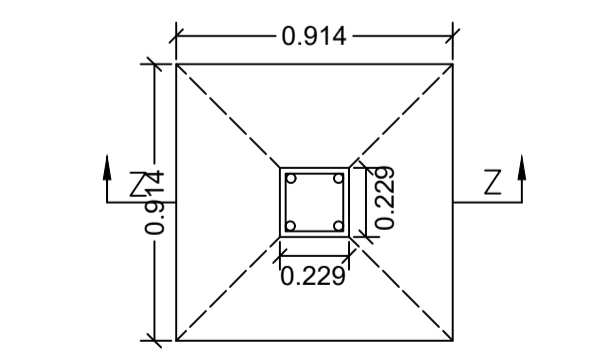

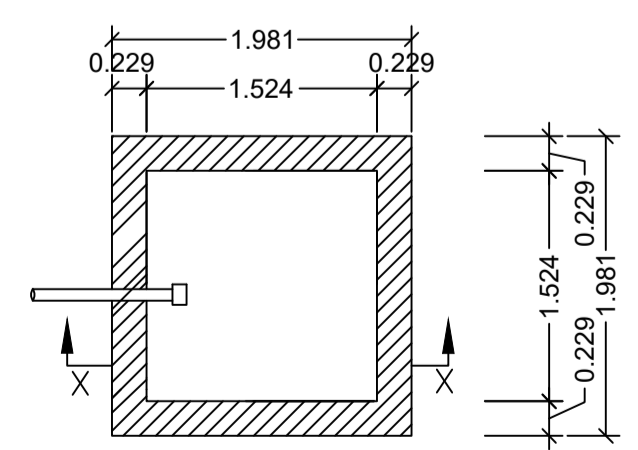

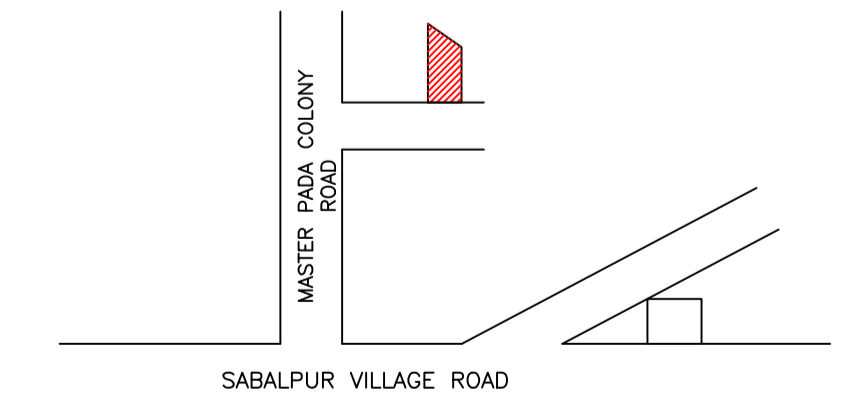
DETAILS OF SEPTIC TANK (SCALE - 1:50)
